1. Final Wheat Location Differentials for 2014/15 marketing season.

Subsequent to market notice A2080 of 04 September 2014, this notice serves to release the final location differentials for wheat for the 2014/15 marketing season.

The JSE received limited written submissions which were discussed with the parties concerned. As a result there is no material change to the initial proposal as presented in market notice A2080.

The final Return Load Factors (RPT's) adopted from the maize model are presented in the sliding scale below:

a. Randfontein Location Differential Rates (LDR)

Combining the RPT formula above with rail-road ratios, and rail rates, we were in a position to determine an LDR from Randfontein for each of the 171 JSE-registered wheat storage facilities. The Western Cape-Reef LDR due to the distance from Randfontein is not driven off the same formula and was derived based on feedback received from the market.

The table below shows the aggregate rand per kilometer (RPK) rates specific to Randfontein for road transport that we obtained from the industry and used in our calculations:

b. Paarl Location Differential Rates (LDR)

Similarly with the CAPE wheat contract, we were in a position to determine an LDR from Paarl for each registered wheat silo considering only road rates. Refer to attached spreadsheet for the final rates.

2. Standard Storage Rates

The repeat from the previous notice, the standard storage rate for the marketing season 1 October 2014 - 30 September 2015 will increase based on the June 2014 PPI for manufacturing output as published at the end of July 2014, namely 8.1%. Therefore the standard storage rate applied to outstanding storage in completion of a futures contract will be **77 cents per ton per day**.

Please ensure that when making delivery of JSE silo receipts issued in the previous marketing season, all storage is paid up to and including **30 September 2014**.

3. Grade Discount Rates

The grade discounts will only be finalised after the 15th September as per the agreed methodology.
