#### 3.3 Northern Cape

- ➤ The reported case in Douglas was not FAW.
- > Hartswater was confirmed with FAW.
- > Extension offices are out scouting in the province.

### 3.4 Mpumalanga

- Confirmed areas: Hazyview, Nkomazi, Bushbuckridge, Schoemanskloof (Tonga area).
- Extension offices are out scouting in the province.

#### 3.5 North West

Detected areas: Potchefstroom

#### 3.6 Free State

Detected areas: Vredefort, Parys, Petrus Steyn

#### 3.7 Limpopo

Widespread in Limpopo (Thabazimbi)

➤ Unconfirmed: Three crops (potato, onion and tomato) reported to be affected and need to be followed up.

➤ Areas detected: Roodeplaat, Bronkhorstspruit, Onderstepoort, Nigel Responsible role players – DAFF, all PDA's
