**Weens Covid-19 kon die NAMPO Oesdag 2020 nie vanjaar plaasvind nie en is daar opsies aan uitstallers gegee om hul standplaasfooie oor te dra na NAMPO 2021 of dit te laat terugbetaal.**

**Sommige uitstallers het van hul NAMPO 2020 standplaasfooie gebruik om vir hul NAMPO Virtueel standplaas te betaal.**

**Uitstallers sal normaalweg hul uitstallerskontrakte vir NAMPO 2021 ontvang, wat die normale standplaasfooie vir 2021 sal aandui. ### **Baristas & Popcornmasjiene**

**Geen popcornmasjiene sal in die toekoms op standplase toegelaat word nie. Slegs baristas (koffiemasjiene) van nie groter as 1.7KW of 10 Amps sal op buite standplase toegelaat word. Hierdie besluit is eerstens geneem vanweë die hoeveelheid krag wat baristas gebruik en tweedens na klagtes van ons kiosks (skole en kerke) dat die uitgee van gratis koffie ens. hul verkope drasties beïnvloed.**

**Ons glo u het begrip vir ons besluit. Geen ketels of huishoudelike perkoleerders sal op standplase binne-in sale toegelaat word nie.**

### **Inbring van koeldranke en waterbotteltjies**

**Daar word al hoe meer gevind dat uitstallers hul eie koeldranke en waterbotteltjies die week voor NAMPO op hul standplase inbring. Indien uitstallers koeldranke of waterbotteltjies aan potensiële kliënte of personeel wil voorsien, moet dit direk by Graan SA bestel word en sal dan van die sentrale koeldrankstoor voorsien word. Hierdie reël sal streng in die toekoms toegepas word.**

### **Mediese dienste voor en tydens NAMPO**

**Mediese dienste sal vanaf 3 – 16 Mei 2021 op NAMPO Park beskikbaar wees. Uitstallers en kontrakteurs sal voor genoemde datum self verantwoordelik wees vir enige mediese ongevale wat mag plaasvind op standplase. Die NAMPO Oesdagkomitee het ook besluit om 'n "Safety & Health Officer" vir NAMPO 2021 aan te stel om standplase wat gebou word te inspekteer en te kyk of dit aan die nodige wetlike vereistes voldoen. Dieselfde reëls en regulasies wat vir bouversele geld, sal nou ook hier geld.**



### **GRAIN SA'S NAMPO HARVEST DAY 2021 : TUESDAY 11 - FRIDAY 14 MAY 2021**

NAMPO has always been a platform where agriculture could come together, do business and think strategically about agriculture's future. The covid-19 pandemic brought new challenges to everyone, forcing society to think differently about doing business, such as presenting a first NAMPO Virtual in September 2020.

The NAMPO Harvest Day is scheduled for 11 – 14 May 2021 at NAMPO Park and we look forward to welcoming exhibitors and visitors again to NAMPO Park.

#### **NAMPO Website**

Exhibitors are invited to visit the NAMPO website at [www.nampo.co.za](http://www.nampo.co.za) for all exhibitors info, the terrain layout, hall layouts, and rules ext.

#### **General Rules & Regulations**

The extent and size of the NAMPO Harvest Day makes it essential that all exhibitors must please adhere to the rules of the NAMPO Harvest Day.

By signing the attached contract, you undertake to keep to the General Rules & Regulations for exhibitors at the NAMPO Harvest Day. It is therefore in your best interest to study it which is available on [www.nampo.co.za](http://www.nampo.co.za). **You have to ensure that all personnel involved in your exhibition are also aware of the rules and adhere to them.**

#### **Products to be exhibited**

Products to be exhibited have to be specified in full. Only products that the organisers have approved may be exhibited and the Harvest Day Committee retains the right to decide whether products specified on exhibitor's contracts may be exhibited or not.

#### **Exhibitor's agreements & payments**

**Due to covid-19 could the NAMPO Harvest Day 2020 not take place this year, and exhibitors were given the options to transfer their stand fees to NAMPO 2021 or have them refunded.**

**Some exhibitors have used some of the NAMPO 2020 stand fees to pay for their NAMPO Virtual stand.**

**Exhibitors will receive their exhibitor contracts as usual, which will indicate the normal stand fees for NAMPO 2021. If you have arranged for your stand fees to be transferred to NAMPO 2021, then you will only receive an exhibitors contract. Exhibitors who have requested a refund of stand fees will receive an exhibitor contract and invoice for NAMPO 2021.**

Attached herewith please find your exhibitor's contract for the NAMPO Harvest Day 2021. **A copy of your completed and signed agreement with the payment should reach the office of Grain SA at NAMPO Park not later than 30 NOVEMBER 2020.** Payment can be made directly into the Grain SA bank account. **The NAMPO Harvest Day Committee retains the right to cancel stands if you're completed and signed contract as well as full payment have not been received in time. The deadline will be adhered to strictly; you should therefore ensure that the completed contract and payment reach us in good time.**

#### **Baristas & Popcorn Machines**

**No popcorn machines will be allowed on stands in future. Only baristas (coffee machines) not exceeding 1.7Kw or 10 Amps will be allowed on outdoor stands. This decision was made firstly because of the amount of power used by baristas and secondly complaints from our kiosks (schools and churches) that the handout of free coffee etc. have a drastically impact on their sales.**

**No kettles or percolators will be allowed on stands inside halls.**

#### **Bringing in of cold drinks and water bottles on stands**

**We note that exhibitors are increasingly bringing in their own cold drinks and water bottles on stands the week before NAMPO. If exhibitors want to provide cold drinks or water bottles to potential clients or staff, then they should order it through Grain SA and will it be supplied from the NAMPO soft drink store. This rule will be strictly enforced in future.**

#### **Medical services before and during NAMPO 2021**

**Medical services will be available at NAMPO Park from 3 – 16 May 2021. Exhibitors and contractors will be responsible for any medical accidents that may occur on stands before the said date.**

**The NAMPO Harvest Day Committee has also decided to appoint a Health & Safety Officer for NAMPO 2021, who will be responsible for the inspection of stands and to see if it meets the necessary legal requirements. The same rules and regulations that apply to building sites will now also apply here.**

#### **NAMPO Caravan Park**

The Harvest Day Committee also reminds exhibitors that the space in the NAMPO Caravan Park is limited and that reservations for the caravan park can now be made. Exhibitors are requested to contact the following numbers for a reservation;


