School Groups Visiting NAMPO

The organizers have no control over school groups visiting NAMPO. School groups pay the normal entry fees and do not receive any discounts.

In order to control school groups better, it is planned to set up a tent at the North & South Gate, where school groups will receive orientation in advance, as well as the rules of NAMPO. Goodie bags with promotional items from exhibitors will be distributed to school children, before entering the terrain, in order to prevent school children from asking exhibitors for promotional items on their stands.

NAMPO Park Accommodation

The possibility is investigated of setting up accommodation blocks at NAMPO Park for exhibitors staff during NAMPO. These units can also be used by the exhibitors throughout the year at NAMPO Park for farmer's days, functions and seminars. WIFI To Exhibitors

We receive many requests from exhibitors for the provision of WIFI to exhibitors. The organisers are currently installing a reliable WIFI-system for the Grain SA Office Block, Guesthouse, Grain SA Premises and Access Gates. It is planned to extend this system to the rest of the terrain in the future, but will it not be in place for 2023.

Rental Of Forklift

It is planned to appoint a service provider who exhibitors can contact directly for the rental of a forklift before and after NAMPO. Once a service provider is appointed, contact details will be communicated to exhibitors.

NAMPO Coffee Shop

Following requests from exhibitorss and the public for the serving of good and exclusive coffee on site, we decided to set up a Coffee Shop at Gate 2 this year. It will also attract more feet to this part of the terrain.

Exclusive Restaurant For Exhibitors

Exhibitors also expressed the need for an exclusive restaurant for exhibitors where exhibitors can take their clients or guests for lunch. This venue will be created in a designated area in the Fanie Ferreira Hall and more information and contact details will be provided later.

Clause 2g – NAMPO General Rules & Regulations

It is increasingly noted that exhibitors who exhibit at NAMPO at the same time exhibit at other markets next the R30 route between Bothaville and Orkney.

This is a violation of clause 2g in the General Rules and Regulations for exhibitors at NAMPO;

2g Exhibitors may not have a dual exhibition while exhibiting at NAMPO in a 100km radius from NAMPO Park
