### **RESEARCH COORDINATOR (PRETORIA)**

The Research Coordinator will be responsible for the coordination and development of grain research projects and priorities in areas such as crop improvement, plant health, climate resilience, biosecurity, data and analytics, and human capital development. The role will require verbal, digital and written communication and engagement with stakeholders to address research needs and share outcomes. Additionally, the role will support the Research Coordination team by reviewing and analyzing research projects for quality and relevance, overseeing monitoring and evaluation processes and by implementing related activities across Grain SA's broader research portfolio.

The specific duties of the Research Coordinator are as follows, but is not limited to:

#### **Research Project Development and Management**

- Coordinate research stakeholders and beneficiaries throughout the research project lifecycle, ensuring alignment with the sector needs.
- Facilitate the design, inception, and implementation of new research projects, ensuring alignment with industry needs and Grain SA's objectives.
- Collaborate with external researchers to address technical areas and provide feedback, ensuring research projects meet the required quality standards.
- Source project funding to ensure financial sustainability and appropriate resource allocation.
- Monitor project timelines and deliverables, ensuring all research initiatives are completed according to the schedule and scope.
- Compile detailed reports (including financial information) on research progress and outcomes.

#### **Stakeholder Engagement and Communication**

- Communicate and advocate the technical details of agricultural research to government departments, industry stakeholders, and internal working groups through meetings, presentations, and other forums.
- Write articles and create innovative content to communicate the technical aspects of grain and oilseed research, enhancing industry knowledge, awareness and engagement.
- Participate in the internal and industry-related meetings, representing Grain SA's research interests and contributing to the broader agricultural discourse.
- Communicate project progress with the Research Coordination team, ensuring challenges are addressed and the projects remain on track.

#### **Research Quality, Evaluation, and Knowledge Sharing**

- Evaluate research outputs critically, assessing quality, impact, and project deliverables.

- Conduct literature and evidence reviews to inform research and innovation within the grain and oilseed industry.
- Remain up to date on current findings and emerging trends and facilitate knowledge sharing and continuous improvement.
- Promote collaboration among researchers, institutions, and stakeholders, fostering a culture of shared knowledge to enhance research outcomes.
- Undertake ad hoc tasks to promote and advance grain and oilseed research in South Africa, contributing to the growth and sustainability of the sector.
