

# **REGULATION ROADMAP**



### 1947 - 1980

- Act 36 implemented in 1947
  - Establishes the Office of the Registrar
- Amended in 1977 to enhance regulatory oversight
  - Granted additional power to the registrar to control sales, imports and the use of agri-remedies
- 1980 Pest Control Operators (PCO) Introduced

## 2011

- Pest Control Operator Regulations (February 18, 2011) clarify PCO responsibilities.
- Introduces exemptions for farm employees working on their employer's property unless handling hazardous remedies.



# RESTRICTED AGRICULTURAL REMEDIES

### 2023

## Introduction of "Restricted Agricultural Remedies"

- August 23, 2023: DALRRD publishes new criteria for classifying restricted agricultural remedies.
- Restricted remedies are acutely toxic and require PCO registration for both use and purchase.
  - Farmers are not exempted from PCO certification requirements.

### 2024

### Introduction of "Restricted Agricultural Remedies"

- Following the incident of poison-related deaths the president ordered investigations
- DALRRD & Dept. of Health (DOH) inspectors begin rigorous inspections into the Agricultural remedies supply chain.
- Croplife SA starts workshops and communication campaigns to guide members on compliance



# SALES OF RESTRICTED AGRICULTURAL REMEDIES

- ONLY registered PCOs are allowed to purchase the restricted remedies
- If PCO is unavailable, a designated farm owner/ worker may purchase the restricted remedy on behalf of the PCO, but the following conditions must be met:
  - On the initial purchase, the PCO must accompany the designated farm owner/ worker to the supplier or distributor.
  - The PCO needs to submit a certified PCO registration certificate and a signed letter indicating that the PCO has given the designated individual permission to purchase any remedy on their behalf.
  - The supplier will keep these documents to make the next purchase easier.
- The sales restriction only applies to the farm workers, owners or anyone else who will be applying these remedies (end-users of the product).
- Distributors, agents, or middlemen who are reselling the remedies are not required to be registered as PCOs.



# PEST CONTROL OPERATORS (PCOs)

## Jan 2025

### Full Implementation and Compliance Monitoring

- Farmers must ensure a qualified PCO is present when using restricted remedies.
  - Sales of restricted remedies are now strictly limited to registered PCOs.
  - PCO registration processes are being prioritised by the Registrar's office.
- All industry players are urged to align with the new regulations to avoid legal consequences.

#### How do I become a PCO?

- 1. Pay the application fee of R 2 986.00 Submit to DALRRD
- 2. Prepare a resume.
- 3. Complete the relevant accredited course

\*Exemption for persons holding a diploma/ degree in entomology, pathology, crop protection, weed science and other relevant qualifications.

4. Obtain Practical Experience (6-12 months) under PCO supervision.


#### Alternatively...

Grain SA & Industry Training Day (Work in progress) 1-day practical training

- 5. Pass a medical exam by a qualified practitioner.
- 6. Obtain a PCO license in the Agriculture and Forestry category.

### Which course should I enrol in?

- 1. Pest Management Academy
  - 3 Days classroom, E-learning (Own Pace)
- 2. Pest Control Industries Training Academy
  - 3 Days classroom or E-Learning (30 days)
- 3. DeltaTrax Projects
  - 3 Days classroom or E-learning (30 days)
- 4. Grain Training Institute
  - 2 weeks classroom, E-Learning 6 months



# WHAT ACTIONS ARE THE INDUSTRY AND GSA CURRENTLY TAKING?

## Currently

 Grain SA, together with industry members have requested a phase-in period from the registrar.

### What to expect?

- Communication from the registrar on approval/disproval of a phase-in period.
- Should the request be granted an 18-month phase-in period will be applicable.
- The phase-in period will be re-evaluated 9
  months after approval.

What is expected from industry?

- The industry must address current challenges such as:
  - Communication with affected members on certification procedure.
  - Conveying to affected members the affected remedies.
  - Encouraging growers to consider alternative remedies.
  - Providing information on training.
